In *Adair v United States*[] and *Coppage v Kansas*[] the US Supreme Court over powerful dissents, [] asserted the Constitution empowered employers to require employees to sign contracts promising they would not join a union. The federal right to collective bargaining by a labor union elected by its employees, is meant to reduce the inherently unequal bargaining power of individuals against organizations to make collective agreements.
